3-2. Describe how the CoC determined that this project should be eliminated and include the date the project applicant was notified. (limit 2500 characters)

The Project grantee sent a letter to the CoC stating they would not be renewing the Opportunity Home project under the FY23 NOFO. They determined that they were able to serve this population with funds they have under another project. They requested to reallocate funds to an expansion for Steps III to accommodate the number of families served with funds from Opportunity Home. During the previous grant period for STEPS III, BWS spent all of the funding before the end of the grant cycle due to the client's needs and the rent increase across Summit County.

We also want to reallocate the funds from Opportunity Home back to the CoC and create a new TH-RRH program for victims of human trafficking. We want to explore using funds from the DV Bonus grant to assist with fully funding this initiative. Over the last couple of years, the Summit County community has seen an increased need to provide specialized services to survivors of human trafficking, and access to safe and affordable housing is a priority. The goal is to establish a transitional house for survivors of human trafficking where they will have access to wrap-around services and permanent housing.
